REPORTER'S TRANSCRIPT OF PROCEEDINGS

DANIEL EITNIER, 1 having been first duly sworn by the 2 Foreman of the Grand Jury to testify to 3 the truth, the whole truth and nothing 4 but the truth, testified as follows: 5 6 7 EXAMINATION 8 9 BY MR. KOOT: What is your name, sir? 10 Q. My name is Daniel Eitnier. 11 Α. Spell your last name. 12 Q. E-i-t-n-i-e-r. 13 Α. And what is your occupation, sir? 14 0. I'm the director of corporate Α. 15 surveillance for Primadonna. 16 And how long have you been engaged in 0. 17 that occupation? 18 Ten years. Α. 19 And what are some of the duties of the 0. 20 corporate -- I'm sorry, the director of corporate 21 surveillance, right? 22 23 Α. Yes, that's correct. What are some of your duties? 0. 24 25 Α. I oversee the operation, the

surveillance operation of Buffalo Bill's Casino, 1 Primadonna Casino, and Whiskey Pete's Casino. 2 So when we go towards California from 0. 4 here and head towards Stateline which is now known 5 as Primm, I guess? 6 Α. Yes. 7 P-r-i-m-m? 0. Α. That's correct. Before you get to California, there are 9 Q. 10 three properties situated there? 11 Α. Yes. And that is all part of one 12 Q. 13 corporation? Α. Yes, it is. 14 And then you -- you are in charge of 15 the surveillance of all three properties? 16 That's correct. 17 Q. What is the -- where is the physical 18 set-up wherein the surveillance is monitored? 19 There is a surveillance room for 20 Buffalo Bill's at Buffalo Bill's in the basement, 21 and there is another surveillance room at Primadonna 22 for Primadonna and Whiskey Pete's. 23 0. And what does this physically -- when 24

you're inside that one at Primadonna, what are you

looking at, a bunch of TV's and VCR machines? 1 We have over 50 monitors and a hundred 2 sixty VCR's. We record approximately 400 or so 3 4 cameras from Whiskey Pete's and Primadonna. Record 5 and observe any activities that could happen on the 6 casino floor, the hotels, back of the house, and 7 arcade areas. Q. How about in the arcade area itself, 8 how many monitors? And by monitors we're talking 9 10 about cameras, right? Monitors -- well, monitors, when I talk 11 Α. 12 about monitors it's a TV screen. 13 0. Okay. When I say cameras, you know, we're 14 looking at the cameras, you know, but we have VCR's 15 that -- the recording devices that record on, 16 dedicated. They're not always up. The shots that 17 are recording are not always up on a monitor. 18 Let me use the correct terminology 0. 19 then. 20 In the Primadonna is there a 21 video arcade? 22 Α. Yes. 23 And where is that physically located? 24 Could you give us some directions? Once we are 25

1	BY A JUROR:
2	Q. Yeah.
3	You mentioned that no one can
4	enter or exit the bathroom area without being
5	seen
6	A. Yes, that's correct.
7	Q by the camera?
8	But it would appear to me by
9	looking at the TV screen, it would be possible to
10	move between the men's room and women's room without
11	coming into view of the camera; is that possible?
12	A. No.
13	The left-hand side of the ladies
14	room were three soda machines pushed up against the
15	wall and on the right-hand side of the men's room
16	they would walk right into that construction wall.
17	They have to come into view of that particular
18	camera.
19	BY MR. KOOT:
20	Q. I think what the Grand Juror member
21	meant, perhaps you could, without being seen, go
22	from the men's room and ladies room and back and
23	forth without being seen from the camera? I could
24	actually walk

I'm sorry. Yes, between the men's and

1	ladies room. Yes, that's correct.
2	Q. We simply do not capture the doors of
3	the restroom?
4	A. That's correct.
5	BY A JUROR:
6	Q. You had stated that a total of eight
7	women entered the restroom during this 24 minutes.
8	How many males entered the restroom area during the
9	24 minutes in question?
10	A. That I wouldn't have. I don't have
11	those numbers.
12	BY MR. KOOT:
13	Q. Is that captured there or not? Do we
14	have a continuous running on this particular tape
15	A. Yes, we did.
16	Q from the time that Jeremy Strohmeyer
17	and Sherrice entered until Jeremy Strohmeyer exits?
18	A. Yes.
19	Q. So if the Grand Jury wishes to view the
20	tape on their own they can do that and count?
21	A. Yes.
22	Q. Thank you.
23	BY A JUROR:
24	Q. This particular tape ended at 4:13.
25	Does another camera or tape recorder take over
