The following is the transcription of a tape-recorded interview conducted by Detective P. Ramos, P#799, LVMPD Homicide Detail, on 05-29-97 at 1810 hours. The persons present during this interview are Justin Ware; his parent, John and Earline Ware;

Detective Sergeant Keeton, P#505; Detective J. Vaccaro, P#1480; and Detective Ramos.

- Justin, I wanna start this interview by asking you if you know it's being recorded. Q.
- A. Yes.
- Okay. Uh, as you know, we're here investigating a murder that occurred in Prim, Q. Nevada over the weekend and it involves a friend of yours by the name of Jeremy

Strohmeyer. Is that right?

A.	I got real nervous. I, I don't know. I didn't wanna like think it was him 'cause he's
	one of my good friends, so I was concerned about him but I don't know, in the back
	of my mind, there could've been a possibility that he would've done it but I didn't
	wanna make that assumption yet 'cause
Q.	Tell me what makes you say that in the back of your mind there was a possibility
	that he could've done that.
A.	Just the way like uh, I don't know. Dave Cash and him used to joke
	about like a lot of stuff, like little girls and stuff and, uh

A.	Just not like they joking around like, uh, on the Internet like stating like oh, she's
	pretty hot for a little girl, that I'd have sex with her. Stuff like that.

Q. Right. Tell me why you think David didn't, uh, let anybody know right away after this has happened. I mean he obviously knew something had happened in there and they were in town for a whole nother (sic) day.

A. Yeah.

- Q. There was a lot of coverage on this because it was such a serious incident. Uh, so even though David may not have known that the little girl was killed when he saw Jeremy in the stall with her, I mean there had to come a time within the next 12 to 24 hours that he knew what had happened.
- A. Uh-huh. I think he got nervous.
- Q. Okay.
- A. I think he got scared and didn't wanna... I think through his mind that he would've, if he, if he would told right then, that he would've gone to jail too.
- Q. Uh-huh.
- A. But... That's, that's the reason I don't think he told anybody.

Okay. ___ Uh, let's talk a little bit about what you know as far as Jeremy and, uh, his interest on, you know, America On-Line and, and what we had talked about earlier, these comments that he would make about sex with little girls. A. Uh-uh. He usually just joked about it. He wasn't, I didn't really think he was that serious about it 'cause I used to joke around it and I was just, I'd laugh at it like just picturing is that his joke. But he really didn't say anything about like actually doing

it, like being serious about it. So...

Q. Okay. Alright. I can't think of any other questions. Sergeant Keeton, do you have

any questions?

WK. You told me earlier that you thought that he did have a, a definite interest in

pornography that was on the Internet.

A. Uh-huh.

WK. And, uh, you thought that you, you had heard that he printed out, uh, some of the

information in regards to, uh, pornography from his, uh, from his computer.

- A. About, uh, I think a couple, I don't know how long ago wuh— it was but, uh, his, I guess his parents put him on some kind of medication, some kind of a, I don't know, some kinda drug to keep him up 'cause he used to be, he was sleeping a lot.

- A. And so, and he was taking that quite a bit during like, 'cause like when he wouldn't wake up, he'd take one-
